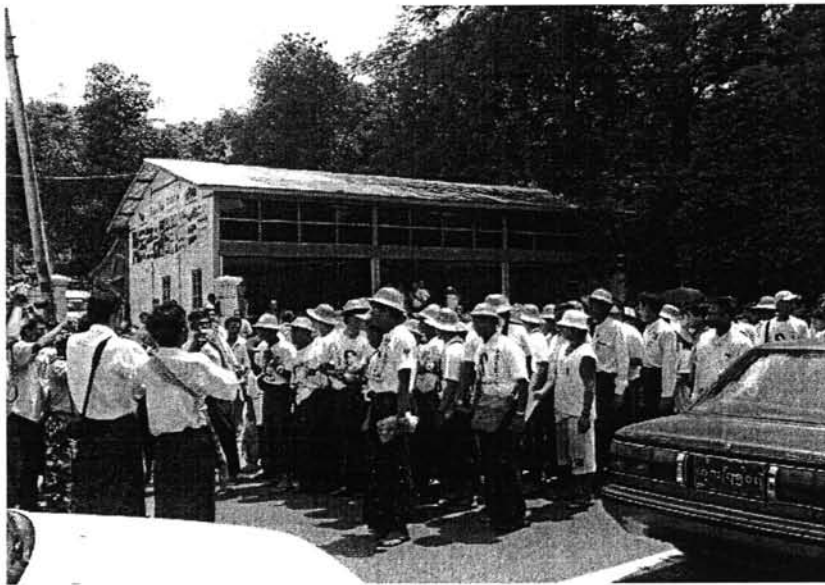

The logo of 88 Generation Students in Burmese



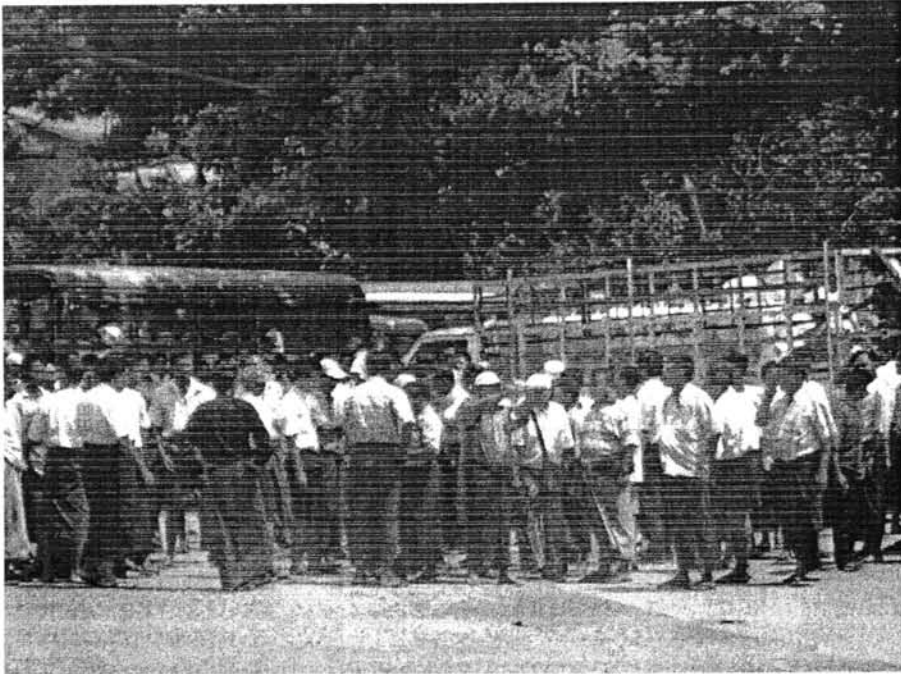

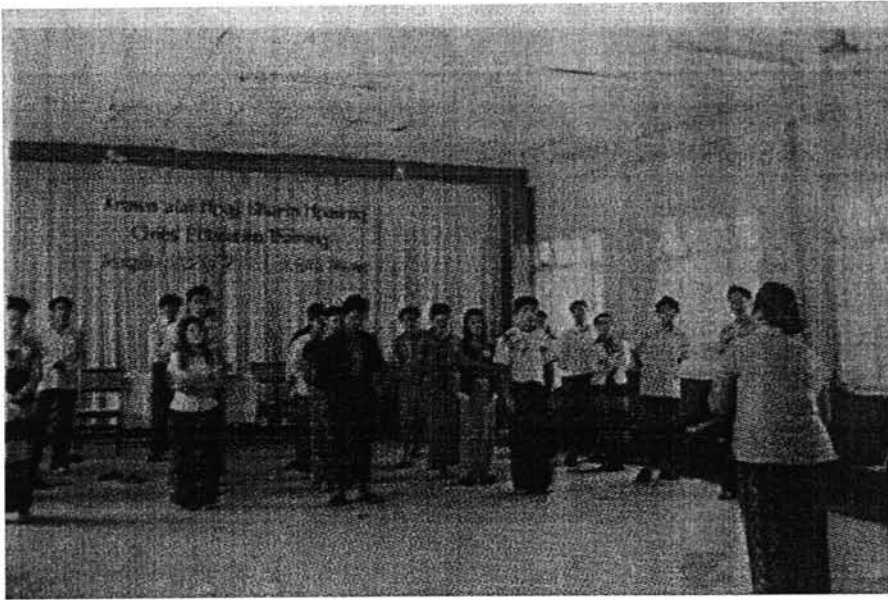

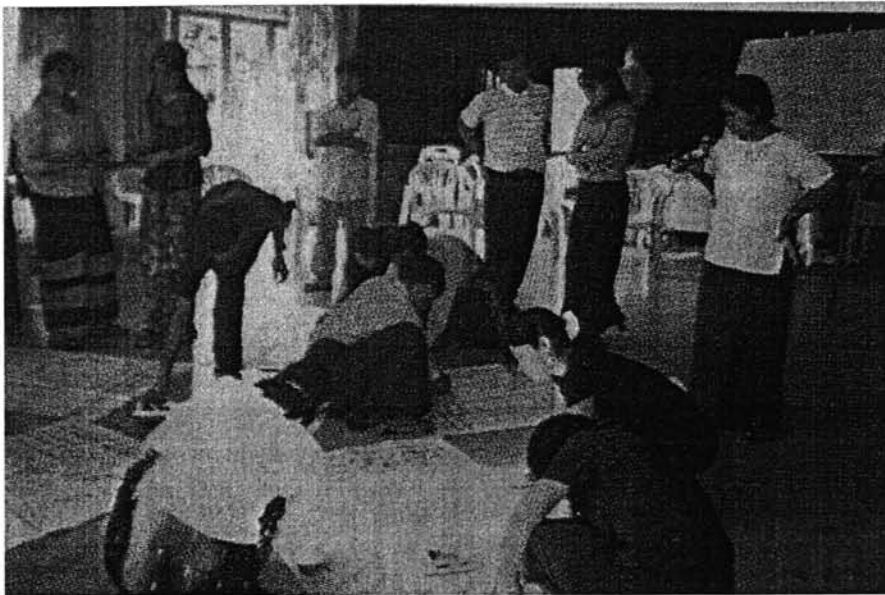
